CONSULTANCY SERVICE TO UNDERTAKE MID-TERM EVALUATION FOR AYINET'S – REHABILITATING COMMUNITIES AND VICTIMS FOR EFFECTIVE RECOVERY (RECOVER II) PROJECT

PROJECT TITLE: REHABILITATING COMMUNITIES AND VICTIMS FOR EFFECTIVE RECOVERY (RECOVER II)

1. Introduction:

African Youth Initiative Network (AYINET) with funding from Democratic Governance Facility (DGF) is implementing the second phase of Rehabilitating Communities and Victims for Effective Recovery (RECOVER II) for 3 Years from May 2018 to May 2021, aimed at accelerating revitalization of post conflict community, enabling healing and community's participation in Transitional Justice processes. RECOVER II also among others seeks to promote leadership that reflects diversity of our country, linking issues of peace, justice, governance, human rights, accountability; and above all working with the Government and Development Partners to domesticate and demonstrate progress against SDG16+ targets and indicators; and UN SCR2250.

AYINET is seeking for an external consultant to undertake a mid-term evaluation of RECOVER II project. The mid-term evaluation will help to assess the impact and success of the project that has been implemented half way.

2. Scope and objectives:

The project covers four Sub- Regions of Teso, Lango, Acholi and West Nile. The following districts are covered in the above sub- regions; **Lango** (Lira, Alebtong, Oyam, Otuke, Dokolo, Kole, Apac), **Acholi** (Agago, Pader, Lamwo, Kitgum, Gulu, Amuru, Omoro), **Teso** (Kaberamaido, Amuria, Soroti) and **West Nile** (Yumbe, Moyo, Adjumani, Arua, Nebbi).

Across the Sub- Regions, the project offers opportunity to 2,220 survivors of war to benefit from Medical Rehabilitation through Surgeries, 4,500 survivors of war to access psychosocial counseling and awareness on Transitional Justice and Gender power created to over 1,000,000 people living within the project coverage.

RECOVER II has the following specific objectives;

- **Objective 1:** To enhance physical and emotional healing of war victims in greater northern Uganda.
- **Objective 2:** To promote meaningful community's participation in Transitional Justice processes
- **Objective 3:** To mobilize and engage youth at risks as leaders and game changers
- **Objective 4:** To Promote Opportunities for Women's Empowerment and Recovery (Gender- POWER)

3. Project Outcome:

As the project implementation goes on, it is also important to know that the project intends to achieve the following outcome;

- a) Improved physical and mental health of post conflict community members in the Greater North
- b) Enhanced community participation in the national Transitional Justice processes
- c) Inter-ethnic and inter-generational dialogue on-going as harmony and tolerance promoted, and
- d) Improved rights of women and men, and Transitional Justice processes is gender inclusive

- Ability to synthesize complex information and communicate it effectively to diverse audiences; ability to design and implement efficient work flows and procedures.
